Applications

The HD135 heat alarm is for use as a warning device in residential applications. Each alarm has a solid state piezo signal to warn and alert the household to the presence of threatening heat.

The HD135 alarm is designed to detect heat that results from an actual fire. Heat alarms are intended for use as supplements to smoke alarms. This unit cannot detect smoke or toxic gases, therefore, do not rely solely on this heat alarm to provide a warning of fire.

In the event AC power fails, a 9VDC battery will provide proper alarm operation for a minimum of a 24-hour period.

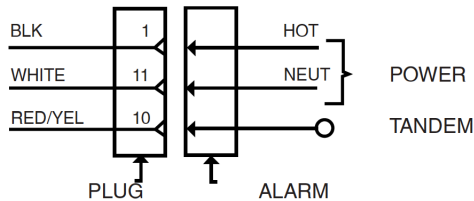

Photoelectric Smoke Alarm with Visual Signaling Appliance

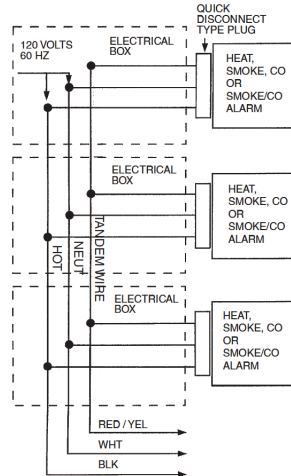
Wiring Diagrams

Tandem Installation

CAUTION:

All alarms in a tandem installation must be controlled by the same fuse or circuit breaker. Otherwise tandem units will not operate. Tandem will operate in the event of an AC power failure if battery is connected to the alarm. **LIMITATIONS:** A heat alarm can be connected to a maximum of 12 smoke and 5 other heat or CO alarms, to total not more than 18 interconnected devices. Do not exceed 1125 feet between the first and last alarm. **NOTE:** A maximum of five (5) alarms of either model 9120/9123 and 7100/7103 with the relay options (F) and 3 heat alarms may be tandem interconnected. Wire used for interconnecting shall be in accordance with Article 300.3(b) and Article 210 of the National Electrical Code (NEC) and NFPA 70.

Architect & Engineering Specifications

The heat alarm shall be a Gentex Model HD135/HD135-223 or approved equal which shall provide at least the following features and functions.

- Nominal rating shall be 135°F fixed temperature.
- The alarm shall utilize a bimetalic sensing element when the surrounding air temperature reaches 135°F, the unit will go into alarm.
- The alarm shall have a 9VDC alkaline battery as a back-up in the event building power is lost.
- The 9VDC battery impedance shall be verified by the circuit of the heat alarm.
- The alarm shall provide an indicator when the battery is low in power or high impedance or is missing.
- A solid state piezo alarm rated at 90dBA at 10ft.
- A visual LED monitor (condition indicator) will slow pulse in normal operation and rapid pulse in alarm.
- The alarm shall have tandem capabilities of up to 18 units.
- Can be interconnected with AC alarms, Gentex GN-200/GN-203, GN-300/GN-303, CO1209, GN-503, S1209, 9120/9123, 7100/7103, 710CS/7109CS, 713CS/7139CS, 9220/9223 and 7200/7203 alarm series, or other Gentex HD135 units.
- The manufacturer shall provide other compatible heat alarm models or smoke alarm models with the following optional features: a) 135°F isolated thermal with normally opened contact for remote connection to local alarm or annunciator; b) 135°F integral thermal; c) auxiliary Form A/Form C relay contact for initiating remote functions and annunciation; d) relay option that is capable of activation by tandem interconnect wire. Thermal sensor shall be self-restoring.
- Unit must be ANSI/UL 539 listed for both wall and ceiling mount.
- Unit shall also meet all requirements of the State of California Fire Marshal.

All equipment shall be completely factory assembled, wired and tested, and the contractor shall be prepared to submit a certified letter testifying to this condition. Smoke alarms which do not meet all of the requirements of this specification will not be considered.
